Time-Enduring Gifts

For those who want to help sustain Community Health Center as a resource in years to come, a bequest is the ideal way to make a substantial gift without jeopardizing your ability to meet current and future financial obligations. It is the simplest form of gift planning that can have a substantial impact long after you need the assets. You can help fund a new project or a specific program, or you can give to CHC's Endowment Fund, which supports access to patient care, facility improvements, new programs and staffing, while keeping an eye on our long-term sustainability.

There are several ways to support Community Health Center through planned giving, including:

- A bequest: designating a specific dollar amount or assets (real estate or personal property). This can be advantageous to give a certain percentage of your estate to prevent unintentionally reducing the provisions you made for other beneficiaries.
- Charitable gift annuity: a simple gift contract between a charity and a donor in which the charity makes a fixed payment for life to the donor or someone of their choice, in return for a gift of cash or securities.
- Making CHC a beneficiary: often the best strategy for making low-cost, high value charitable gifts by helping reduce estate and income taxes. This can be done by making CHC a whole or partial beneficiary of a trust, IRA or life insurance.
- Charitable lead trust: Irrevocable trust designed to provide financial support to one or more charities for a period of time, with savings on estate and gift taxes.
